And Therefore Be It Resolved: Chief and Council have reviewed and support this project to be funded from the Project and Development Account.





Description: To provide the Chief and Council with monthly honorariums.


Purpose: To fund honorariums for the Chief and Council.

Therefore: Council hereby certifies that prior to this request that Council identified, applied and budgeted for grants or other funding as may be available.






